PHC Institutional Approval and Ethics Approval is required **before** HIM can provide access to patient charts for research study purposes. A 'Request for Retrieval/Access to View Patient Health Records Form' will need to be completed and will be issued by HIM. If the research study involves patient charts discharged after April 1, 2006 (for all care levels except Residential Care), PHC PCIS access is required as these patient charts are only viewable electronically.
